WHEREAS, Republic Act No. 10742 or The Sangguniang Kabataan Reform Act of 2015 highlighted the creation of the LYDC and Local Youth Development Office thru Chapters III and IV, respectively;

WHEREAS, sec, 3 of RA No. 10742 ot the SK Reform /act of 2015 states that LYD Plan shall initially drafted by the SK Federation and finalize by the LYDC and approved by the local sanggunian and shall be anchored on the Phil Youth Development Plan;
