RESOLUTION NO. 003-S2021

A RESOLUTION APPROVING THE REQUEST OF HONORABLE EDGAR S. SAN LUIS TO EXTEND THE DEADLINE FOR THE RENEWAL OF BUSINESS CLEARANCE, MAYOR'S PERMIT AND OTHER RELATED LICENSES AND PERMIT FROM JANUARY 2 TO MARCH 31, 2021 PURSUANT TO THE PROVISION OF LOCAL GOVERNMENT CODE OF 1991 (RA 7160) AND REVENUE CODE OF THE MUNICIPALITY OF SANTA CRUZ LAGUNA TO MINIMIZE THE FLOCK OF APPLICANTS AND GIVE TIME TO RAISE THE NEEDED AMOUNT FOR THE PAYMENT OF SAID PERMIT

WHEREAS, an endorsement by Honorable Edgar S. San Luis presented to the Sangguniang Bayan dated January 6, 2021 requesting a change of schedule for the renewal of business permit from January 2 to March 31, 2021 to minimize the flock of applicants and to give sufficient time to raise the needed amount for the payment of permit of their respective businesses;

WHEREAS, the renewal of particularly small business licenses and payment of mayor's permit fees and other related charges commence at the beginning of each year and ends on the 20th of January pursuant to the provision of the Local Government Code of 1991 (RA 7160);

WHEREAS, said request was deliberated upon by Lupon sa Kautusan at Batas and Lupon sa Mabuting Pamamahala, Pamublikong Asal at Pamublikong Pananagutan during the committee meeting

WHEREAS, in the interest of business proprietors the said Committee after its evaluation recommended for the approval of the request of extension to March 31, 2021.

NOW THEREFORE, on motion of Honorable Alan T. Pamatmat (Chairman of Committee on Laws and Ordinances), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Efrén L. Diaz, Hon. Ramon D. Tan and Hon. Lucena R. Odejar and with the approval of all members of the Sangguniang Bayan, it was

RESOLVED: To approve the request of Honorable Edgar S. San Luis to extend the deadline for the renewal of Business Tax, Mayors Permit and Other related Charges from January 2 to March 31, 2021 pursuant to the provision of Local Government Code of 1991 (RA 7160) and Revenue Code of the Municipality of Santa Cruz, Laguna to minimize the flock of applicants and give time to raise the needed amount for the Payment of said Permit.
