## MUNICIPAL ORDINANCE NO. 06- S2022

**AN ORDINANCE GRANTING TEMPORARY CLOSURE OF STREETS OF M.H. DEL PILAR CORNER ALFONSO STREET AND L. TALEON STREET FOR THE PURPOSE OF CONDUCTING NIGHT MARKET IN ORDER TO STIR THE ECONOMIC ACTIVITY OF RETAILERS AFFECTED BY PANDEMIC FROM MAY 1, 2022 TO JUNE 30, 2022 FROM 5:00 IN THE AFTERNOON TILL 12:00 IN THE EVENING.**

**WHEREAS**, an endorsement dated April 25, 2022 from Mr. Melvin O. Bonza, Municipal Administrator by the authority of the Municipal Mayor Hon. Edgar S. San Luis favorably endorsing the approval of the closures of streets for conducting a night market in the specified streets to wit:

*Covered period* : from May 1, 2022 to June 30, 2022 from 5:00 in the afternoon to 12:00 in the evening

*Covered streets/area*. M. H. Del Pilar St. cor Alfonso St. to M. H. Del Pilar St. cor. L Taleon St.

*Rationale*: To stir economic activity for our retailers who are affected by Pandemic

**WHEREAS**, the same endorsement was referred to Committee on Market for deliberation with Hon Efren L. Diaz as Co-chairman moving for its approval.

**NOW THEREFORE**, upon motion of Hon. Efren L. Diaz (Vice-Chairman of the Committee on Market and Slaughterhouse), duly second by Hon. Louie C. De Leon, Hon. Ramon D. Tan, Hon. Lucena R. Odejar and Hon. Alan T. Pamatmat, with the approval of the members of the Sangguniang Bayan present,

BE IT enacted by Sangguniang Bayan of Santa Cruz, Laguna in its session assembled, that :

**SECTION 1.** That M. H. Del Pilar Streets corner Alfonso St. and Taleon St. shall be temporarily closed for purposes of conducting Night Market from May 1, 2022 to June 30, 2022 from 5:00 in the afternoon to 12:00 in the evening to stir economic activity for our retailers affected by pandemic

**SECTION 2.** That Santa Cruz Traffic Management shall provide appropriate traffic and public information signages in coordination with the Philippine National Police and other appropriate agencies of Local Government Unit.

**SECTION 3.** That this Ordinance shall take effect immediately upon its approval.

**ORDERED:** Let copies of this resolution be furnished the Honorable Sangguniang Panlalawigan, the Honorable Mayor, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development, the Municipal Accountant, the Municipal Engineering Office, the Public Market Administrator, Santa Cruz Traffic Management, the Philippine National Police and all other concerned, for their information and appropriate action.
