## RESOLUTION NO. 333 - S2021

**RESOLUTION APPROVING THE PROGRAM/PROJECT FOR THE ESTABLISHMENT SANTA CRUZ COMMAND AND OPERATION CENTER TO BE APPLIED TO LANDBANK LOAN WITH A TOTAL AMOUNT OF PHP22,000,000.00 FOR THE INSTALLATION OF COMMAND AND CONTROL EQUIPMENT AND MACHINE APPROVED ANNUAL INVESTMENT PLAN CY 2021 FOR THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.**

**WHEREAS**, a letter request was received by Sangguniang Bayan dated June 30, 2021 from Hon. Mayor following up the endorsement of the approval of the project to be applied to Land Bank Loan that is Santa Cruz Command and Operation Center which will be the center of emergency coordination with the barangays and other agencies;

**WHEREAS**, the said facilities will include the detail of PNP, BFP, MHO, SCTMO and other relevant personnel for community monitoring, coordination, communication, resource dispatch, early warning dissemination traffic and market monitoring and emergency response;

**WHEREAS**, request was referred to Sangguniang Bayan Committee on Peace and Order and Public Safety, Committee on Transportation and Communication, Committee on Good Governance and Committee on Finance, Budget and appropriation for study;

**WHEREAS**, after careful evaluation the said committees recommended the approval of its request;

**WHEREAS**, said recommendation was objected by **Hon. Patrocinia S. Kalaw, Hon. Lea A. Almarvez** and **Hon. Mark Anthony Joven** instead recommended an additional workforce in the Office of the MDRRM; additional rescue vehicle to attend to emergencies and communication system in every barangay coming from the operational budget of the Municipal Government of Santa Cruz, Laguna;

**WHEREAS**, an objection calls for the division of the Body and the same was presented to the Body for votation and the result is **Hon. Ramon D. Tan; Hon. Alan T. Pamatmat; Hon. Efren L. Diaz; Hon. Lucena R. Odejar** and **Hon. Louie C. De Leon** voted for the approval of the establishment of Command and Operation Center as part of the program to be finance by the Land Bank loan incorporated in the existing AIP 2021 (ELA) of the Municipal Government;

**WHEREAS**, a majority vote of five (5) Councilors approved of the establishment of command center and operation center and a vote of three (3) Councilors objected for the passage of the resolution.

**NOW THEREFORE**, on motion of Hon. Ramon D. Tan (Chairman of Committee on Peace and Order and Public Safety), duly seconded by Hon. Lucena R. Odejar, Hon. Alan T. Pamatmat, Hon. Efren L. Diaz, and Hon. Louie C. De Leon it was:

**RESOLVED**, as it is hereby **RESOLVED** to approve THE PROGRAM/PROJECT FOR THE ESTABLISHMENT OF SANTA CRUZ COMMAND AND OPERATION CENTER- PROGRAM TO BE APPLIED TO LANDBANK LOAN WITH A TOTAL AMOUNT OF PHP22,000,000.00 FOR THE INSTALLATION OF COMMAND AND CONTROL EQUIPMENT AND MACHINE APPROVED ANNUAL INVESTMENT PLAN CY 2021 FOR THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.
