## RESOLUTION NO. 334 - S2021

RESOLUTION APPROVING THE ESTABLISHMENT OF MUNICIPAL AGRICULTURAL COMPLEX AND PRODUCTION/POST HARVEST FACILITIES WITH RICE PROCESSING CENTER TO BE APPLIED TO LANDBANK LOAN IN THE AMOUNT OF TEN MILLION PESOS (PHP 10,000,000.00) FOR THE MUNICIPALITY OF SANTA CRUZ LAGUNA.

WHEREAS, a letter request was received by Sangguniang Bayan dated June 30, 2021 from Hon. Mayor following up the endorsement of the approval of the project to be applied to Landbank Loan the establishment of the Municipal Agricultural Complex and Production/Post Harvest Facilities with Rice Processing Center;

WHEREAS, in order to surpass this pandemic, the establishment of this facilities will ease the burden of the farmers in marketing produce and avoiding the challenges posed by the presence of the middlemen. It is envisioned as an income generating facility which will ensure the availability of food that is sufficient for the entire municipality during this time of surge;

WHEREAS, the request was referred to Sangguniang Bayan Committee on Agriculture, Fishery and Cooperative and Committee on Finance, Budget and Appropriation for study and deliberation;

WHEREAS, after careful evaluation the committee recommended the request for its approval;

NOW THEREFORE, upon motion of Hon. Lea A. Almarvez (Chairman of Committee on Agriculture, Fishery and Cooperative), duly seconded by Hon. Alan T. Pamatmat, Hon. Ramon D. Tan, Hon. Lucena R. Odejar, Hon. Mark Anthony P. Joven, Hon. Patrocinia S. Kalaw and with the approval of members of Sangguniang Bayan, it was:
