**MUNICIPAL ORDINANCE NO. 04- S2022** 

AN ORDINANCE WAIVING THE RENTAL FEES OF THE MUNICIPAL PUBLIC MARKET OF SANTA CRUZ LAGUNA FOR DAILY OCCUPANCY AND LEASE OF FIXED STALLS AND SPACES UNDER SECTION 5A (03) CHAPTER V - THE IMPOSITION OF FEES AND RENTAL RATE FEES OF DAILY OCCUPANCY AND LEASE OF MARKET FIXED STALLS AND SPACES EMBODIED IN THE LOCAL REVENUE CODE AND DURING PANDEMIC TO GIVE ASSISTANCE TO MARKET VENDORS AND STIMULATE THE ECONOMY DURING THIS TIME OF SURCE STIMULATE THE ECONOMY DURING THIS TIME OF SURGE.

WHEREAS, in view of the continuing rise of confirmed cases of COVID-19, the serious threat to the health, safety, security and lives of our constituents, the long term adverse effects on the means of livelihood and the severe disruption of economic activities;

WHEREAS, public market spanning stalls and other establishment would need to close their doors in order to help prevent the spread of the virus;

WHEREAS, market revenues has dramatically decreased due to the impacts of covid-19 and therefore this measure will serve as relief by granting moratorium on their rents during this time of pandemic;

NOW THEREFORE, upon motion of Hon. Mark Anthony P. Joven (Chairman on Committee on Market and Slaughterhouse), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Patrocinia S. Kalaw and Hon. Alan T. Pamatmat and with the approval of the members of the Sangguniang Bayan, it was

BE IT ORDAINED BY SANGGUNIANG BAYAN OF SANTA CRUZ LAGUNA IN ITS REGULAR SESSION ASSEMBLED:

SECTION 1. The Municipal Government of Santa Cruz Laguna waives the imposition of rental fees in the Municipal Public Market for daily occupancy and lease of market fixed stalls spaces as embodied in section 5A (03) Chapter V under Imposition of Fees during this time of pandemic

SECTIION 2. Rental fees shall be adjusted and be implemented on March 1-31, 2022

SECTION 3. Repealing Clause. All Ordinances, Resolutions, Local Executive Orders or Administrative issuances or parts thereof, inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

SECTION 4. Separability Clause. If for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby, shall continue to be in full force and effect.

SECTION 5. Effectivity Clause. This Ordinance shall take effect immediately upon its approval
