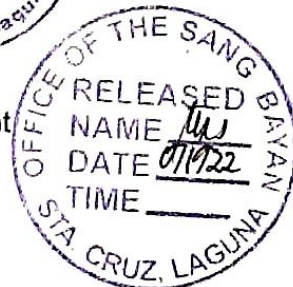

WHEREAS, Section 80 of the Local Government Code of 1991 provides that "There shall be established in every province, city or municipality a Personnel Selection Board to assist the Local Chief Executive judicious and objective selection of personnel for employment as well as for promotion and in the formulation of such policies as would continue to employees welfare;

WHEREAS, as member of the PSB shall make a systematic assessment of the competence and qualifications of candidates for appointment to the corresponding level of positions in order to assist the appointing authority in the judicious and objective selection of candidates for appointment;
