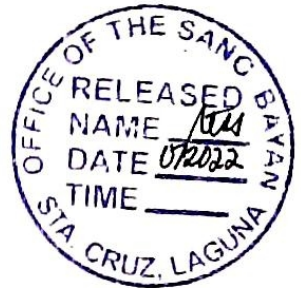

RESOLUTION APPROVING THE REALIGNMENT IN THE OFFICE OF THE SANGGUNIANG BAYAN IN THE AMOUNT OF SEVENTY FOUR THOUSAND PESOS (Php 74,000.00) FROM REPAIR AND MAINTENANCE – BUILDING AND OTHER STRUCTURE (MAINTENANCE AND OTHER OPERATING EXPENSES – (MOOE)) TO MEMBERSHIP DUES AND CONTRIBUTION OF THE ELECTED COUNCILORS TO PHILIPPINE COUNCILORS' LEAGUE (PCL) NATIONAL OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA SUBJECT TO LEGAL LAWS RULES AND REGULATION.

WHEREAS, a letter request from the Honorable Vice Mayor Laarni A.
