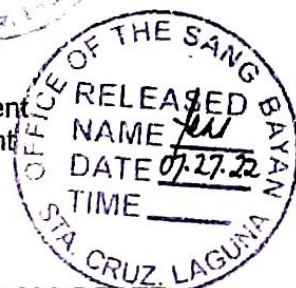

RESOLUTION NO. 293- S2022

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. EDGAR S. SAN LUIS TO ALLOCATE FUNDS FROM 20% MUNICIPAL DEVELOPMENT FUND SURPLUS 2021 AMOUNTING TO ONE MILLION FOUR HUNDRED FORTY THOUSAND PESOS (PHP 1,440,000.00) TO BE ALLOCATED TO THE PROPOSED PROGRAM/ PROJECT THE DISPOSAL OF RESIDUAL WASTE AT SANITARY LANDFILL IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA SUBJECT TO LEGAL LAWS RULES AND REGULATIONS.

WHEREAS, an endorsement from Honorable Mayor Edgar S.
