A RESOLUTION GRANTING AUTHORIZATION TO THE LOCAL CHIEF EXECUTIVE HON. EDGAR S. SAN LUIS TO ENTER AND SIGN A DEED OF DONATION BETWEEN THE DEPARTMENT OF HEALTH, DULY REPRESENTED BY EDUARDO C. JANAIRO, MD, MPH, CESO III AND THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA IN BEHALF OF HONORABLE CONGRESSMAN BENJAMIN AGARAO OF THE 4TH DISTRICT OF LAGUNA, PERTAINING TO THE GRATUITOUS TRANSFER OF ONE (1) UNIT AMBULANCE TO SAID MUNICIPALITY.

WHEREAS, the Local Government Unit are partners of the Department of Health in implementing health programs and in delivering quality health services;

WHEREAS, in order to enhance and improve the delivery of health services and upgrading the said health facilities and to make them more responsive to the needs of the constituents the provision of ambulance shall contribute to the functionality and delivery of quality Health care in the Municipality of Santa Cruz, Laguna;

NOW THEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of the Committee on Health, Nutrition and Sanitation), duly seconded by all the members of the Sangguniang Bayan present, it was

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the Resolution Granting Authorization to the Local Chief Executive Hon. Edgar S. San Luis to enter and sign a Deed of Donation between the Department of Health, duly represented by Eduardo C. Janairo, MD, MPH, CESO III and the Municipal Government of Santa Cruz, Laguna in behalf of Congressman Benjamin Agarao of the 4th District of Laguna and to accept the gratuitous transfer of one (1) unit, ambulance to said Municipality with the following undertakings;

- 1. Ensure that the ambulance is properly classified and recorded in the books of assets of the LGU or health facility.
- 2. Ensure that within six(6) months upon receipt of the ambulance, said ambulance is licensed in its name and its own expense, in accordance with DOH Administrative Order regarding the Rules and Regulations Governing the Licensure of Land Ambulances and Ambulance Service Providers;
- 3. Ensure the availability of health personnel, supplies and other operational expenses necessary for the operation and maintenance of the ambulance and the equipment therein;
- 4. Ensure the rational use of the ambulance is utilized in accordance with the definition and standards provided in the abovementioned DOH Administrative Order;
- Ensure the rational use of the ambulance within the municipality or locality to maximize its benefit to the residents needing ambulance service;
- Apply for the renewal of the ambulance vehicle registration with the LTO after three years(3) using its own resources. The Donee may transfer the vehicle registration under its name;
- Designate the MHO/LGU as the focal person who will be coordinating with the DPH Regional Office for purposes of program monitoring and evaluation.
