RESOLUTION NO. 300- S2022

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HONORABLE EDGAR S. SAN LUIS OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA TO SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT A MEMORANDUM OF AGREEMENT WITH PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION (PHILMECH) FOR POSTHARVEST EQUIPMENT OF ONE (1) MULTI-STAGE RICE MILL AND TWO (2) RECIRCULATING DRYERS FROM THE DEPARTMENT OF AGRICULTURE.

WHEREAS, the Philippine Center for Postharvest Development and Mechanization (PHILMECH) is an attached agency of the Department of Agriculture mandated to generate, extend and commercialize appropriate and problem-oriented agriculture and fishery postharvest and mechanization technologies, practices and systems and responsible for spearheading the development of postharvesting with the aim of fostering global competitiveness and sustainable agriculture and fishery sectors;

WHEREAS, PHILMECH is task to spearhead and implement the mechanization component of the Rice Competitiveness Enhancement Fund (RCEF) pursuant to Republic Act 11203 known as the Rice Tarification

WHEREAS, the Sangguniang Bayan of Santa Cruz Laguna has passed Resolution No. 334-S2021 dated August 2, 2021 through the request of Honorable Mayor Edgar S. San Luis, the establishment of Municipal Agricultural Complex and Production/Post harvest facilities with Rice processing center which will be applied to Land Bank loan in order to ease the burden of the farmers in marketing produce and avoid the presence of middlemen. It is envisioned as an income generating facility which will ensure the availability of food that is sufficient for the entire municipality;

WHEREAS, in view of this facility, the Municipal Government of Santa Cruz Laguna qualifies as a beneficiary from among the stakeholders to receive projects in the implementation of PHILMECH program and to provide an area of at least 550 square meters for a period of 15 years and the construction of building/warehouse to consined the machineries;

NOW THEREFORE, upon motion of Hon. Norman T. Tolentino (Chairman, Committee on Agriculture Fisheries and Cooperative), duly seconded by all the members of the Sangguniang Bayan, present.

RESOLVED: To authorize THE MUNICIPAL MAYOR HONORABLE EDGAR S.
