AN ORDINANCE APPROVING THE REALIGNMENT OF TERMINAL LEAVE FUND BENEFITS AMOUNTINGS TO THREE MILLION ONE HUNDRED EIGHTY TWO THOUSAND ONE HUNDRED FORTY SIX PESOS AND SEVENTY TWO CENTAVOS (Php 3,182,146,72) TO BE ALLOCATED FOR THE IMPLEMENTATION OF LBC NO. 143 - THIRD TRANCHE COMPENSATION ADJUSTMENT OF THE MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA FOR THE MONTHS OF JULY TO DECEMBER 2022 INCLUDING GSIS PREMIUMS AND YEAR END BONUS (Php2,176,700.29); PHILHEALTH DIFFERENTIAL FROM 3.5% (P1,683,982.23) to 4.5% (P1,953,812.40); RECLASSIFICATION OF THE POSITION OF TWO MIDWIFE III SG 11/8 TO SG 13/8 (P179,475.76) & SG 11/1 TO SG 13/1 (P167,193.061) AND FUNDING OF TWO CO-TERMINOUS POSITION OF PRIVATE SECRETARY II WITH SALARY GRADE 15 FOR THE MONTHS OF SEPTEMBER TO DECEMBER 2022 (388,847.44) SUBJECT TO LEGAL LAWS RULES AND REGULATION AND PURSUANT TO CIVIL SERVICE OMNIBUS RULES AND REGULATIONS.

WHEREAS, presented before the Sangguniang Bayan is the request from Honorable Mayor Edgar S. San Luis, for realignment of funds amounting to Php 3,182,146.72 from the savings of the Terminal Leaves Benefits allocated before May 9, 2022 elections intended for elective and co-term positions;

WHEREAS, there is a need to realign & allocate funds for the implementation of LBC No. 143 dated January 3, 2022 – the Third Tranche Compensation Adjustment covering the months of July to December 2022 including the fund allocation for GSIS Premiums, Year End Bonus, additional fund for Philhealth which increases from 3.5% to 4%, for all officials and employees of the Municipal Government of Santa Cruz, Laguna;

WHEREAS, said request was referred to the Committee on Finance, Budget and Appropriation for study and deliberation;

WHEREAS, after thorough study and evaluation, the realignment is recommended for its approval after submitting important documents supporting the request.

NOW THEREFORE, upon motion of Hon. Rizaldy N. Kalaw (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by all the members of the Sangguniang Bayan present, be it was,
