AN ORDINANCE APPROVING THE REALIGNMENT OF THE AMOUNT OF FOUR MILLION SEVEN HUNDRED EIGHT THOUSAND THIRTY EIGHT PESOS AND FORTY ONE CENTAVOS (Php 4,708,038.41) FROM THE 2021 SURPLUS WHICH SHALL BE USED TO ALLOCATE FUNDS FOR ADDITIONAL FUNDS FOR OTHER SUPPLIES AND MATERIALS (Php1,000,000.00) AND OTHER PERSONAL BENEFITS - LOYALTY AWARD (Php678,038.41) IN THE OFFICE OF THE MAYOR; TRAVELLING EXPENSES - FOREIGN (Php30,000.00) IN THE INFORMATION OFFICE; ADDITIONAL FUND FOR GASOLINE (Php2,500,000.00) IN GENERAL SERVICE OFFICE; ADDITIONAL GASOLINE IN THE OFFICE OF SANGGUNIANG BAYAN (PHP350,000.00) AND IN THE OFFICE OF THE VICE MAYOR AN ADDITIONAL FUND FOR GASOLINE (Php150,000.00) SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

WHEREAS, an endorsement from Honorable Mayor Edgar S. San Luis dated July 22, 2022, a request for realignment with a total amount of Php 4,708,038.41 from 2021 Surplus;

WHEREAS, said request was referred to the Committee on Finance, Budget and Appropriation for study and evaluation;

WHEREAS, after thorough evaluation and study said request is recommended for its approval;

NOW THEREFORE, on motion of Hon. Rizaldy N. Kalaw (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by all the members of the Sangguniang Bayan present, it was
