**RESOLUTION NO. 324- S2022**

**A RESOLUTION REQUESTING THE OFFICE OF THE HONORABLE RISA HONTIVEROS, SENATOR OF THE REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUNDS IN THE AMOUNT OF FIFTY MILLION PESOS (Php 50,000,000.00) FOR THE CONSTRUCTION OF NEW PUBLIC MARKET OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.**

**WHEREAS**, the Municipality of Santa Cruz, Laguna is the capital town of the Province of Laguna with an area of more or less 3,860 hectares and a population of 123,574 (PSA 2020) classified as First Class Municipality of the Lone Fourth District of Laguna;

**WHEREAS**, public market is a significant Economic Enterprise which is expected to provide major and additional revenue to the municipality;

**WHEREAS**, the Municipality of Santa Cruz, Laguna incurred losses for the past years in the operation of the market due to pandemic wherein we are forced to close the public market to protect the safety of the public specifically the stall owners and the customer from adverse effect of Covid-19, which resulted to inefficient revenue collection and inappropriate management;

**WHEREAS**, the entire structure of Santa Cruz Public Market is deteriorating due to wear and tear thereby needing a thorough rehabilitation/ construction of the New Public Market which is the priority project of the LGU for it lacks financial capability to implement aforesaid project to be able to compete with nearby malls and market in neighboring cities and municipalities;

**WHEREAS**, market vendors and their families of Santa Cruz, Laguna depend on their meager income and upgrade of the said public market which will result to improvement of well-being;

**WHEREAS**, part of thrust of the Local Government Unit (new set of management) is to operate and manage a clean public market which can afford affordable basic commodities and a wide range of cheap goods;

**NOW THEREFORE**, on motion of Hon. Rizaldy N. Kalaw (Chairman of the Committee on Finance, Budget and Appropriation), duly seconded by Hon. Mark Anthony P. Joven, Hon. Norman T. Tolentino and Hon. Esmeraldo C. De Las Armas, Jr. and with the approval of the members of the Sangguniang Bayan present, it was

**RESOLVED AS IT IS HEREBY RESOLVED:** To request the Office of the Honorable Risa Hontiveros, Senator of the Republic of the Philippines in the amount of Fifty Million Pesos (Php50,000,000.00) for the Construction of New Public Market of the Municipality of Santa Cruz, Laguna.
