WHEREAS, Section 20 Article II of the Constitution provides that "the State recognizes the indispensable role of the private sector, encourages private enterprise and provides incentive to needed investment".

WHEREAS, Municipal Ordinance No. 20-S2021 recognizes private sector participation in infrastructure development and social-service related projects of the State and Local government units (LGU's) to what is know as Public-Private Partnership (PPP).

WHEREAS, Public-Private Partnership (PPP) is a framework that engage the private sector acknowledge the structure of government in ensuring that social obligation are met and successful sector reforms and public investments achieve;

WHEREAS, A strong PPP allocates tasks, obligations and risks among the public and private partners in an optimal way which recognizes that the public and the private sectors have certain advantages relative in performing specific tasks which provides social responsibility, environmental awareness, local knowledge and an ability to mobilize political support.
