RESOLUTION NO. 430- S2022

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH, THE CENTER FOR HEALTH DEVELOPMENT 4A- CALABARZON DULY REPRESENTED BY ARIEL L. VALENCIA, MD, MPH, CES CO III. DIRECTOR IV DOH QMMC PROJECT 4, QUEZON CITY WHICH PROVIDES FOR THE FUND TRANSFER FOR THE PAYMENT OF HEALTH EMERGENCY ALLOWANCE (HEA) WHICH IS BASED ON PUBLIC HEALTH EMERGENCY BENEFITS AND ALLOWANCES FOR HEALTH CARE WORKERS AS PROVIDED FOR IN **REPUBLIC ACT NO. 11712.**

WHEREAS, Act No. 11712 provides for the payment of Health Emergency Allowance (HEA), Sickness and Death Compensation and other benefits for public and private Health Care Workers (HCW) during the Covid19 Pandemic and other future public health emergencies with retroactive application starting July 1, 2021;

WHEREAS, the MOA provides for the payment of the qualified Health Workers in the Municipality of Santa Cruz, Laguna wherein the Center for Health Development shall transfer funds as indicated in the Department Order and in turn the Municipal Government will pay qualified Health Care Workers (HCW) based on DOH guidelines of which the transferred fund must be utilized within one month but not later than December 31, 2022

WHEREAS, an endorsement by Melvin O. Bonza by authority of the Municipal Mayor Hon Edgar S. San Luis dated October 13, 2022 respectfully requesting to the Honorable Members of the Sangguniang Bayan to issue authority to sign a MOA in behalf of the Municipal Government of Santa Cruz, Laguna with Center for Health Development of which was referred to the Committee on Health Nutrition and Sanitation for study and evaluation;

WHEREAS, after thorough evaluation the same is recommended by the Committee to authorize the Municipal Mayor to enter into Memorandum of Agreement.

NOW THEREFORE, on motion of Hon. Esmeraldo C. De Las Armas Jr, (Chairman Committee on Health, Nutrition and Sanitation), duly seconded by all the members of the Sangguniang Bayan present, it was
