RESOLUTION GRANTING AUTHORITY TO HON. MAYOR EDGAR S. SAN LUIS TO SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE RURAL HEALTH UNIT OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA AND LAGUNA STATE POLYTECHNIC UNIVERSITY (LSPU), COLLEGE OF NURSING AND ALLIED HEALTH DULY REPRESENTED BY MARIO R. BRIONES, EdD, UNIVERSITY PRESIDENT TO ALLOW THE USE OF FACILITIES OF RURAL HEALTH UNIT OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA FOR THE TRAINING OF NURSING STUDENTS OF UNIVERSITY AND ALLIED HEALTH.

WHEREAS, an endorsement was received by Sangguniang Bayan dated September 20, 2022 from Melvin O. Bonza, Municipal Administrator by authority of Hon. Mayor Edgar S. San Luis respectfully and favorably requesting to grant authority to Hon. Mayor Edgar S. San Luis to enter and sign a Memorandum of Agreement between the Rural Health Unit 1 and the Laguna State Polytechnic University, College of Nursing and Allied Health to allow the use of the facilities of RHU for affiliation and training of Nursing students of LSPU;

WHEREAS, the MOA provides opportunity for the students of the LSPU to gain experience, training, utilizing all available materials and equipment of RHU without impairing the services to the patients and in turn the University shall submit to the RHU the inclusive dates and area of assignment, name of instructor and the students who will undergo training and to abide with the RHU policies, rules and regulation within its vicinity;

WHEREAS, the MOA shall take effect on June 1, 2022 and shall terminate at the end of business hours on June 1, 2025

WHEREAS, said endorsement was referred to the Committee on Health Sanitation and Nutrition for evaluation
