## RESOLUTION NO. 448 - S2022

A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PLAN (SIP) AUTHORIZING THE SUPPLEMENTAL BUDGET FOR THE RELEASE OF PERFORMANCE BASED BONUS FOR THE YEAR 2021 FOR ELECTED OFFICIALS, PERMANENT, CASUAL EMPLOYEES IN THE AMOUNT OF FIVE MILLION EIGHT THOUSAND EIGHT HUNDRED THREE PESOS AND FORTY EIGHT CENTAVOS (Php5,008,803.48) AND ONE MILLION TWO HUNDRED EIGHTY FIVE THOUSAND PESOS (Php1,285,000.00) FOR EMPLOYEES WHO HAS SERVED THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA FOR MORE THAN TEN (10) YEARS SUBJECT TO EXISTING LEGAL LAWS, RULES AND REGULATIONS.

WHEREAS, Joint Memorandum Circular No. 2021-01 of the Department Of Interior and Local Government and the Department of Budget and Management dated November 22, 2021 provides guidelines on the grant of the Performance Based Bonus for officials and employees of the LGU for fiscal year 2021 to be validated and given in FY2022;

WHEREAS, the National Government continues to acknowledge all public servants for their collective and unceasing participation in and invaluable contribution to the streamline government processes and responsive delivery of services to the public due to this public health pandemic;

WHEREAS, based on the guidelines of JMC No. 2021-01 that the LGU is a passer of the Seal of Good Local Governance applies to all officials and employees holding Regular Plantilla Positions as well as Contractual and Casual; Personnel having an Employer-Employee Relationship with the exception of the barangays;

WHEREAS, an endorsement from Mr. Melvin O. Bonza, Municipal Administrator with the authority of the Municipal Mayor Hon. Edgar S. San Luis requesting for a special session for the approval of the supplemental budget on the grants of Performance Base Bonus and Loyalty Award of employees serving the Municipal Government of Santa Cruz, Laguna for more than ten (10) years with a total of amount of Six Million Two Hundred Ninety Three Thousand Eight Hundred Three Pesos and Forty Eight Centavos (Php6,293,803.48) coming from the fund of Vacant Positions from January to December 2022;

NOW THEREFORE, on motion of Hon. Rizaldy N. Kalaw (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by all the members of the Sangguniang Bayan present, it was
