**MUNICIPAL ORDINANCE NO. 17-S2022** 

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF PORTIONS OF CAILLES STREET FROM THE SANTA CRUZ BRIDGE TO THE FRONT OF THE MUNICIPAL HALL; J. P. RIZAL STREET (FRONT OF ESCOLAPIA BUILDING) AND M. H. DEL PILAR STREET IN FRONT OF MEGA TO THE BACK OF JOLLIBEE FROM DECEMBER 5, 2022 TO JANUARY 6, 2023 FOR THE PURPOSE OF CONDUCTING NIGHT MARKET.

WHEREAS, the Sangguniang Bayan is empowered to temporarily close roads or alleys pursuant to section 21 (a) (c) of the Local Government Code of 1991;

WHEREAS, on December 2, 2022 Sangguniang Bayan Office received a letter from Mr. Melvin O. Bonza, Municipal Administrator recommending the schedule for Night Market from December 5, 2022 to December 15, 2022 to start putting up of goods from 6:00 in the evening to 2:00 morning the following day and from December 16, 2022 to January 6, 2023 to start from 5:00 in the afternoon to 2:00 in the morning the following day;

WHEREAS, the request letter was referred to the Committee on Market and Slaughterhouse for

WHEREAS, after consultation and deliberation the same was recommended for its approval;

NOW THEREFORE, on motion of Hon. Mark Anthony P. Joven, (Chairman Committee on Market and Slaughterhouse), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Alan T. Pamatmat, Hon. Regine S. Regalado, Hon. Patrocinia S. Kalaw and Hon. Lucena R. Odejar and with the approval of the members of the Sangguniang Bayan, it was

Be it ordained by the Sangguniang Bayan of Santa Cruz Laguna in its regular session assembled, that:

SECTION 1. Portion of Cailles Street shall be closed from Santa Cruz Bridge to the front of the Municipal Hall; J. P. Rizal Street (front of Escolapia Building) and M. H. Del Pilar Street in front of Mega to the back of Jollibee for the purpose of conducting Night Market.

SECTION 2. The temporary closure shall start from December 5 -15, 2022, 6:00 in the afternoon till 2: 00 in the morning the following day and from December 16, 2022 to January 6, 2023 from 5:00 in the afternoon till 2:00 in the morning the following day.

SECTION 3. The following conditions shall be implemented:

- a. That a substitute route shall be provided with corresponding plan
- That the alternate route shall be properly maintained for public safety until such duration
- That the Office of the Municipal Administrator shall provide appropriate traffic and public information signages and manpower coordination with the SCTMO and the PNP and other appropriate agencies of the government.
