A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN A MEMORANDUM OF UNDERSTANDING ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH THE COMMISSION ON POPULATION AND DEVELOPMENT CALABARZON HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR ANGELITO S. OBCENA IN IMPLEMENTING THE NATIONAL PROGRAM ON POPULATION AND FAMILY PLANNING TOWARDS AN EFFICIENT AND EFFECTIVE RESPONSIBLE PROMOTION OF MATERNAL HEALTH AND REPRODUCTIVE RIGHTS THIS MUNICIPALITY.

WHEREAS, the Memorandum of Agreement defines the terms in the implementation of the national program on Population and Family Planning including the Population Development Integration and access to Responsible Parenthood and Family Planning Information and Services;

WHEREAS, its primary aim is to improve the policy and program, environment of the local level to ensure its implementation with the technical, financial and monitoring assistance of the Commission on Population, Calabarzon;

WHEREAS, an endorsement dated November 9, 2022 from Mr. Melvin O. Bonza, Municipal Administrator by the authority of the Municipal Mayor Hon. Edgar S. San Luis requesting for an authority to enter into Memorandum of Understanding with the Commission on Population and Development, Calabarzon which cover matters to facilitate the convergence of strategy activities and resources for an efficient and effective provision of Responsible Parenthood and Family Planning and Reduction of Adolescent Pregnancies towards the promotion of Maternal Health and other reproductive rights;

WHEREAS, such request was referred to the Committee on Social Welfare and Development, Family and Women for further study;

WHEREAS, after thorough study said request was recommended for its approval.

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Chairman of Committee on Social Welfare and Development and Family), duly seconded by all the members of the Sangguniang Bayan, it was
