**RESOLUTION NO. 185- S2023**

**A RESOLUTION CONCURRING THE APPOINTMENT OF MRS. SUSANA A. SAULON AS MUNICIPAL ASSESSOR OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA SUBJECT TO CIVIL SERVICE COMMISSION LAWS RULES AND REGULATIONS.**

**WHEREAS**, received by the Sangguniang Bayan dated January 25, 2023 from Mr. Melvin O. Bonza by authority of the Municipal Mayor Edgar S. San Luis concurring the Appointment of Mrs. Susana Saulon as the Municipal Assessor of the Municipality of Santa Cruz, Laguna;

**WHEREAS**, Article 119 of IRR of RA 7160 provides that appointment of Appointive Local Officials, Heads of Offices and Departments in the LGU's shall be appointed by the Local Chief Executive concerned with the concurrence of the majority of all members of the Sanggunian, subject to Civil Service Laws, Rules and Regulations;

**WHEREAS**, one of the qualifications to be appointed as Municipal Assessor, that he must acquire experience in the Real Property Assessment work or in any related field for at least three (3) years in the case of the Municipal Assessor;

**WHEREAS**, the position of Municipal Assessor was vacated due to the retirement of Mrs. Erlinda Belleza;

**WHEREAS**, to fill up subject position is deemed necessary for the Municipal Government of Santa Cruz, Laguna to support the Municipal Mayor in carrying the duties and functions incumbent to the LGU for the general welfare of the constituency as provided in Section 16 of RA 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, from the documents submitted to the Office of the Sangguniang Bayan, the appointee, Mrs. Susana A. Saulon had shown to have met the qualifications set forth by RA 7160;

**WHEREAS**, finding the said appointment to be in order after compliance with existing Civil Service Commission Laws, Rules and Regulation;

**NOW THEREFORE**, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by Hon. Mark Anthony P. Joven and with the approval of the members of the Sangguniang Bayan, it was

**RESOLVED AS IT IS HEREBY RESOLVED**, that the resolution Concurring the Appointment of Mrs. Susana A. Saulon as Municipal Assessor of the Municipality of Santa Cruz, Laguna subject to Civil Service Laws, Rules and Regulations BE APPROVED.
