**RESOLUTION NO. 270-S2023**

**A RESOLUTION AUTHORIZING AND GRANTING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ LAGUNA WITH LANDBANK OF THE PHILIPPINES DULY REPRESENTED BY ITS PRESIDENT AND CHIEF EXECUTIVE CECILIA C. BORRAMEO THROUGH HER DULY AUTHORIZED REPRESENTATIVE BRANCH HEAD BABY MAUREEN P. CASTALONE, INTENDED FOR THE OPENING OF CASH CARD ACCOUNTS FOR JOB ORDER EMPLOYEES.**

**WHEREAS**, as provided for in Rule IX Article 47 of the Local Government Code of 1991, it states that, "no contract may be entered into by the Local Chief Executive in behalf of the LGU without prior authorization by the Sanggunian concern";

**WHEREAS**, on March 15, 2023 an endorsement letter was received by Sangguniang Bayan Office from Municipal Administrator Melvin O. Bonza by authority of the Municipal Mayor requesting for an authority to grant the Honorable Mayor Edgar S. San Luis to enter into MOA with Land Bank of the Philippines for the opening of Cash Card accounts for Job Order employees;

**WHEREAS**, the Municipal Government of Santa Cruz, Laguna desires to avail of the Land Bank "Cash Card", a stored value card that uses magnetic stripe technology containing the Cash Card account data. The value associated with the card can be accessed thru ATM via Point of Sale facility;

**WHEREAS**, the Job Order employees of the Municipal Government of Santa Cruz, Laguna shall pay the amount of One Hundred Fifty Pesos (P150.00) for the Cash Card and shall be valid for ten (10) years and a replacement fee of One Hundred Pesos (P100.00) for lost or damaged card shall be borne by the Cash Card holder;

**WHEREAS**, said endorsement was referred to the Committee on Finance, Budget and Appropriation for evaluation;

**WHEREAS**, after thorough study the same was recommended for its approval;

**WHEREAS**, the Memorandum of Agreement between the Municipal Government of Santa Cruz, Laguna and the Land Bank of the Philippines hereto attached and made an integral part of this resolution;

**NOW THEREFORE**, on motion of Hon. Rizaldy N. Kalaw (Chairman, Committee on Finance, Budget and Appropriation), duly seconded by all the members of the Sangguniang Bayan present, it was

**RESOLVED** as it is hereby **RESOLVED**: To authorize and grant **THE HONORABLE MAYOR EDGAR S.
