RESOLUTION NO. 330-S2023

RESOLUTION APPROVING THE LOCAL YOUTH DEVELOPMENT PLAN OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA FOR CY 2023 - 2025.

WHEREAS, Article II, Section 12 of the 1987 Constitution recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, intellectual and social well-being;

WHEREAS, Republic Act No. 10742 or the Sangguniang Kabataan Reform Act of 2015 highlighted the creation of the Local Youth Development Council (LYDC) and Local Youth Development Office (LYDO) thru Chapters III and IV, respectively;

WHEREAS, Section 3 of Republic Act No. 10742 or the Sangguniang Kabataan Reform Act of 2015 states that Local Youth Development Plan shall initially drafted by the SK Pederasyon and Finalize by the LYDC and approved by the Local Sanggunian and shall be anchored on the Philippine Youth Development Plan;

WHEREAS, on Section 2. 2.17 of Department of Budget and Management Memorandum No. 24 dated June 14, 2021, the Local Youth Development Plan is one of the documents that shall be prepared and submitted by the Local Chief Executives of provinces, cities and municipalities to the Local Sanggunian concerned for budget authorization purposes;

WHEREAS, the Municipal Youth Development Council of Santa Cruz, Laguna finalized and approved the Local Youth Development Plan for year 2023 – 2025 during their session dated March 17, 2023.

NOW THEREFORE, on motion of Hon. Regine S. Regalado (Chairman of Committee on Youth Development), duly seconded by Hon. Norman T. Tolentino and Hon. Ambiel John C. Panganiban and with the approval of the members of the Sangguniang Bayan, it was
