## **RESOLUTION NO. 348-S2023**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE EDGAR S. SAN LUIS TO ENTER AND SIGN A CONTRACT OF LEASE WITH MRS. YOLANDA A. CHING, OWNER OF THE PROPERTY LOCATED IN LOPEZ JAENA STREET, BRGY. POBLACION IV, SANTA CRUZ, LAGUNA TO BE USED AS LOCAL OFFICES FOR MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT (MSWD) AND OTHER OFFICES OF THE MUNICIPALITY OF SANTA CRUZ WITH A MONTHLY RENTAL OF P20,000.00.

WHEREAS, the Hon. Mayor Edgar S. San Luis endorsed to the Sangguniang Bayan for the issuance of a resolution granting him an authority to enter and sign a Contract of Lease with Mrs. Yolanda A. Ching;
