RESOLUTION NO. 349-S2023

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE EDGAR S. SAN LUIS TO ENTER AND SIGN A CONTRACT OF LEASE WITH THE HEIRS OF AGUEDA CASES AND GODOFREDO CASES REPRESENTED BY ANTHONY GODOFREDO CASES III, OWNER OF THE PROPERTY LOCATED AT A. REGIDOR STREET, BRGY. POBLACION III, SANTA CRUZ, LAGUNA TO BE USED FOR PARKING PURPOSES WITH A MONTHLY RENTAL OF P15,000.00.

WHEREAS, the Hon. Mayor Edgar S. San Luis endorsed to the Sangguniang Bayan for the issuance of a resolution granting him an authority to enter and sign a Contract of Lease with the Heirs of Agueda Cases and Godofredo Cases;

WHEREAS, the said endorsement was referred to the Committee on Laws and Ordinance and Committee on Budget, Finance and Appropriation for its discussion and deliberation;

WHEREAS, it was recommended for approval knowing that the Contract of Lease is a renewal of the previous one.

San Luis to enter and sign a Contract of Lease with the Heirs of Agueda Cases and Godofredo Cases represented by Anthony Godofredo Cases III, owner of the Property Located at A. Regidor Street, Brgy. Poblacion IIII, Santa Cruz, Laguna to be used for Parking Purposes with a Monthly Rental of P15,000.00.
