RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM FOR THE SUPPLEMENTAL BUDGET IN THE AMOUNT OF FOUR MILLION ONE HUNDRED SIXTY FOUR THOUSAND THREE HUNDRED THIRTY ONE PESOS AND SIXTY CENTAVOS (Php4,164,331.60) FROM THE 2022 SURPLUS IN THE AMOUNT OF Php19,164,331.60 WHICH SHALL BE USED TO ALLOCATE FUNDS IN THE OFFICE OF THE MAYOR, LOYALTY PAY (Php1,895,000.00); FOOD SUPPLIES EXPENSES (Php1,000,000.00); OTHER SUPPLIES AND MATERIAL EXPENSES (Php1,000,000.00); TRAINING AND SEMINAR EXPENSES (Php 269,331.60) SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

WHEREAS, an endorsement from Honorable Mayor Edgar S. San Luis dated July 3, 2023 is requesting for Supplemental Budget in the amount of Php4,164,331.60 from 2022 Surplus with a total amount of Php19,164,331 60 to be allocated in the Office of the Mayor; Loyalty Pay (Php1,895,000.00); Food Supplies Expenses (Php1,000,000.00); Other Supplies and Material Expenses (Php1,000,000.00); Training and Seminar Expenses (Php 269,331.60) subject to Applicable Laws and Auditing Rules and Procedures;

WHEREAS, there is an urgent need to appropriate the said amount to suffice the expenditures and other previous payables of the Municipal Government of Santa Cruz, Laguna, a call for a Special Session is hereby requested for consideration of the Sangguniang Bayan members.

WHEREAS, said request was referred to the Committee on Finance, Budget and Appropriation for evaluation

WHEREAS, after thorough evaluation and study it is recommended for its approval.

NOW THEREFORE, on motion of Honorable Rizaldy N. Kalaw, (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by Hon. Patrocinia S. Kalaw, Hon. Regine S. Regalado, Hon. Lea A. Almarvez and Hon. Esmeraldo C. De Las Armas, Jr. and with the approval of the members of the Sangguniang Bayan present except Hon. Alan T. Pamatmat who abstained, it was,

RESOLVED: To approve the Supplemental Investment Program for the Supplemental Budget in the Amount of Four Million One Hundred Sixty Four Thousand Three Hundred Thirty One Pesos and Sixty Centavos (P4,164,331.60) from the 2022 Surplus In the amount of Php19,164,331.60 which shall be used to Allocate Funds in the Office of the Mayor, Loyalty Pay (Php1,895,000.00), Food Supplies Expenses (Php1,000,000.00); Other Supplies and Material Expenses (Php 1,000,000.00); Training and Seminar Expenses (Php 269,331.60) subject to Applicable Laws and Auditing Rules and Procedures.
