RESOLUTION NO. 040-S2024

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA THE MEMORANDUM OF AGREEMENT BETWEEN THE LAND BANK OF THE PHILIPPINES AND THE MUNICIPALITY OF SANTA CRUZ, LAGUNA FOR THE USE OF THE ONLINE FACILITY DESIGNED AND OPERATED BY LAND BANK CALLED LAND BANK Link.Biz Portal.

WHEREAS, presented for consideration of the august body is an endorsement from the Hon. Mayor Edgar S. San Luis related to the above request;

WHEREAS, Land Bank is the sole depository and financial settlement bank of the Municipal Government of Santa Cruz, Laguna subject to the conditions mutually agreed upon by the parties,

WHEREAS, under Land Bank Link : Biz portal designed and operated by Land Bank, the Municipal Government of Santa Cruz clients may transact business and / or pay their monetary obligations to the Municipal Government of Santa Cruz, Laguna via the internet using any of the ePayment models being offered by Land Bank, as applicable;

WHEREAS, the use of the on line facility will be in compliance with RA 8792 – "Electronic Commerce Act of 2000, the Anti-Red Tape Act, and the current directions of the President to automatic government systems.

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Vice Chairman of Committee on Finance, Budget and Appropriation), duly seconded by Hon. Norman T. Tolentino, Hon. Ambiel John C. Panganiban, Hon. Lucena R. Odejar and Hon. Alan T. Pamatmat, and with the approval of the members of the Sangguniang Bayan, it was.

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to sign for and in behalf of the Municipal Government of Santa Cruz, Laguna the Memorandum of Agreement between the Land Bank of the Philippines and the Municipality of Santa Cruz, Laguna for the use of the online facility designed and operated by Land Bank called Land Bank Link.biz Portal.

ORDERED: Let copies of this resolution be furnished the Honorable Mayor, the Municipal Treasurer, the Municipal Accountant, the Municipal Planning and Development Coordinator, Land Bank of the Philippines and all other concerned offices, for their information and appropriate action.
