RESOLUTION NO. 052-S2024

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF SANTA CRUZ, LAGUNA THE MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA AND THE UNIVERSITY OF THE PHILIPPINES (UP) DILIMAN THROUGH THE ASIAN INSTITUTE OF TOURISM (ATI) FOR THE MUNICIPALITY TO RECEIVE ASSISTANCE FOR THE CRAFTING OF THE TOURISM DEVELOPMENT FRAMEWORK PLAN (TDFT).

WHEREAS, the Honorable Mayor Edgar S. San Luis endorsed to the Sangguniang Bayan the abovementioned request for the august body's information and perusal'

WHEREAS, the Local Government of Santa Cruz, Laguna is in cognizance of the importance of the sustainable development of the tourism industry thus a need to assess the tourism situation of the municipality;

WHEREAS, UP Diliman through the ATI's Out-Of-Classroom Learning Activities (OCLA) and extension work provides assistance to Local Government Units in crafting Tourism Development Framework Plan (TDFP);

WHEREAS, said endorsement was taken up in the Committee on Tourism wherein its members favorably considered the benefits of the partnership between the Local Government Unit and the university.

NOW THEREFORE: upon motion of Hon. Mark Anthony M. Juangco (Chairman of the Committee on Tourism), duly seconded by Hon. Ambiel John C. Panganiban and Hon. Norman T. Tolentino and with the approval of the members of the Sangguniang Bayan, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis To sign on behalf of the Local Government Unit of Santa Cruz, Laguna the Memorandum of Agreement between the Municipal Government of Santa Cruz, Laguna and the University of the Philippines (UP) Diliman through the Asian Institute of Tourism (ATI) for the municipality to receive assistance for the crafting of the Tourism Development Framework Plan (TDFT).
