## **RESOLUTION NO. 228-S2024**

A RESOLUTION GRANTING AUTHORITY TO MS. MARLENE R. AÑONUEVO, ASSISTANT MUNICIPAL TREASURER, AND DESIGNATED AS OFFICER-IN-CHARGE OF THE MUNICIPAL TREASURER'S OFFICE TO ACT AND / OR SIGN ALL TRANSACTIONS WITH THE LAND BANK OF THE PHILIPPINES, SANTA CRUZ, LAGUNA ON BEHALF OF THE MUNICIPALITY.

WHEREAS, Hon. Edgar S. San Luis endorsed to the Sangguniang Bayan the above urgent request for its approval;

WHEREAS, Memorandum Order No. 047-S2024 designates Mrs. Marlene R. Añonuevo as the Officer-in-Charge of the Municipal Treasurer's Office in view of the official leave of absence of the Municipal Treasurer Mr. Ronaldo O. Valles;

WHEREAS, an authority to Ms. Marlene R. Añonuevo, Assistant Municipal Treasurer, is needed for the continuous flow of transactions in the municipality.

NOW, THEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of the Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by all the members of the Sangguniang Bayan, it was.
