RESOLUTION NO. 262-S2024

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS TO ENTER INTO AND SIGN ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, A MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) DULY REPRESENTED BY ITS REGIONAL DIRECTOR BARRY R. CHUA, MD AND LOCAL GOVERNMENT UNIT (LGU) OF SANTA CRUZ, LAGUNA REGARDING THE SUPPLEMENTARY FEEDING PROGRAM (SFP) FOR CHILDREN AGES 3 - 5 YEARS OLD ENROLLED IN THE CHILD DEVELOPMENT CENTER AND SUPERVISED NEIGHBORHOOD PLAY (SNPs) IN THIS MUNICIPALITY, FOR A PERIOD OF NOT LESS THAN 120 DAYS IN A YEAR.

WHEREAS, presented for consideration of the august body is an endorsement from the Hon. Mayor Edgar S. San Luis for the issuance of a resolution granting him an authority to enter and sign into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD) as aforementioned above;

WHEREAS, the DSWD shall manage, and coordinate / supervise the regional implementation of the Supplemental Feeding Program, designate a Focal Person for the SFP to provide guidance and technical assistance in the implementation of the program;

WHEREAS, the Local Government Unit shall submit a project proposal and a signed master list of the beneficiaries (CY 2024) and the 120 feeding days feeding provision for the identified beneficiaries, and shall include in the project proposal the mode of implementation they will use based on the SFP implementing guidelines;

WHEREAS, the said endorsement was referred to the Committee on Health, Nutrition and Sanitation for evaluation;

WHEREAS, after careful evaluation said endorsement is recommended by the committee for its approval.

NOW THEREFORE, on motion of Honorable Esmeraldo C. De Las Armas, Jr. (Chairman of Committee on Health, Nutrition and Sanitation), duly seconded by all the members of the Sangguniang Bayan present it was,

RESOLVED: To authorize the Hon. Mayor Edgar S. San Luis to enter into and sign on behalf of the Municipal Government of Santa Cruz, Laguna, a Memorandum of Agreement between the Department of Social Welfare and Development (DSWD) duly represented by its Regional Director Barry R. Chua, MD and Local Government Unit (LGU) of Santa Cruz, Laguna regarding the Supplementary Feeding Program (SFP) for children ages 3 - 5 years old enrolled in the Child Development Center and Supervised Neighborhood Play (SNPs) in this municipality, for a period of not less than 120 days.

ORDERED: Let copies of this resolution be furnished the Honorable Mayor, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Officer, the Municipal Accountant, the Rural Health Unit, Department of Social Welfare and Development (DSWD) duly represented by its Regional Director Barry R. Chua, MD and all other concerned offices, for their information and appropriate action.
