

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO SIGN THE MEMORANDUM OF UNDERSTANDING WITH SOLID CEMENT CORPORATION FOR THE COLLECTION AND DISPOSAL OF CONSOLIDATED RESIDUAL PLASTIC WASTES.

WHEREAS, endorsed to the Sangguniang Bayan is the above-mentioned subject matter;
