**RESOLUTION NO. 440-S2024** 

A RESOLUTION RETURNING WITHOUT APPROVAL OF KAUTUSANG BLG. 01-T'2024 OF SANGGUNIANG BARANGAY NG ALIPIT, SANTA CRUZ, LAGUNA AND SANGGUNIANG BARANGAY NG OOGONG, SANTA CRUZ LAGUNA

WHEREAS, pursuant to Section 21 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", the Closure and Opening of Roads must be consistent with the parameters set forth by law;

WHEREAS, the temporary closure of the roads in Sitio 2 and Sitio 3 of Barangay Oogong, Santa Cruz, Laguna, and the Alipit Bridge in Barangay Alipit, Santa Cruz, Laguna is inconsistent with the provisions of Section 21 of the Local Government Code;

WHEREAS, the Sangguniang Barangay of Barangay Oogong, and Barangay Alipit in coordination with GEMTECH through Atty. Henry Alejandro have agreed to formulate and enforce remedial measures to address the excessive dust caused by trucks hauling soil and dirt coming from the Sanitary Landfill;

NOW THEREFORE, on motion of Hon. Laura P. Obligacion (Chairman of Committee on Laws and Ordinances), duly seconded by Hon. Lucena R. Odejar and Hon. Norman T. Tolentino, and with the approval of the members of the Sangguniang Bayan present, it was

**RESOLVED:** To return without approval the Kautusang Blg. 01 T'2024 of the Sangguniang Barangay ng Barangay Oogong, and Sangguniang Barangay ng Barangay Alipit, Santa Cruz, Laguna, and to honor the agreement between the Sangguniang Barangay of Barangay Oogong, Santa Cruz, Laguna, Barangay Alipit, Santa Cruz, Laguna, and GEMTECH, to formulate and enforce remedial measures addressing the excessive dust situation in their area and other relevant concerns.

ORDERED: Let copies of this resolution be furnished the Honorable Mayor, the Sangguniang Barangay ng Barangay Oogong, Sangguniang Barangay ng Barangay Alipit, and GEMTECH for appropriate action.
