

MUNICIPAL ORDINANCE NO. 26-S2024

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF PORTIONS OF CAILLES STREET FROM THE SANTA CRUZ BRIDGE TO THE FRONT OF THE MUNICIPAL HALL AND J. P. RIZAL STREET (FRONT OF ESCOLAPIA BUILDING) FROM NOVEMBER 25, 2024 TO JANUARY 4, 2025 FOR THE PURPOSE OF CONDUCTING A NIGHT MARKET.

WHEREAS, the Sangguniang Bayan is empowered to temporarily close roads or alleys pursuant to Section 21 (a) (c) of the Local Government Code of 1991;

WHEREAS, on November 6, 2024 Sangguniang Bayan Office received an endorsement from Mr. Melvin O. Bonza, Municipal Administrator by the authority of the Honorable Mayor Edgar S. San Luis recommending the schedule for the Night Market from November 25, 2024 to January 04, 2025, to start putting up of goods from 6:00 in the evening to 12:00 in the morning of the following day;

WHEREAS, the endorsement was referred to the Committee on Livelihood, Trade and Industry for study,

WHEREAS, after consultation and deliberation the same was recommended for its approval;

NOW THEREFORE, on motion of Hon. Norman T. Tolentino, (Chairman Committee on Livelihood, Trade and Industry), duly seconded by Hon. Lucena R. Odejar, Hon. Rizaldy N. Kalaw and Hon. Mark Anthony M. Juangco and with the approval of the members of the Sangguniang Bayan, it was

Be it ordained by the Sangguniang Bayan of Santa Cruz Laguna in its regular session assembled, that:

SECTION 1. Portion of Cailles Street shall be temporarily closed from Santa Cruz Bridge to the front of the Municipal Hall and J. P. Rizal Street (front of Escolapia Building) for the purpose of conducting Night Market.

SECTION 2. The temporary closure shall start on November 25, 2024, and end on January 4, 2025, 6:00 in the afternoon until 12:00 in the morning.

SECTION 3. The Office of the Municipal Mayor shall provide appropriate traffic and public information signages and manpower coordination with the SCTMO and the PNP and other appropriate agencies of the government.

SECTION 4. Pursuant to the above conditions, the temporary closure of portions of streets for the purpose of conducting a Night Market is hereby approved.

SECTION 5. This Ordinance shall take effect immediately upon its approval.

ORDERED: Let copies of this resolution be furnished the Honorable Sangguniang Panlalawigan, Honorable Mayor, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Officer, the Municipal Accountant, the Business Permit and License Office, the Market Administrator, SCTMO, PNP, Liga ng mga Barangay, and all other concerned offices, for their information and appropriate action.


