A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA TO SIGN A MEMORANDUM OF AGREEMENT WITH THE CITY SAVINGS BANK, INC. REPRESENTED BY ITS REGIONAL BUSINESS HEAD FOR IV-A, MARISSA T. TOGADO AND TO SIGN OTHER DOCUMENTS PERTINENT TO THE AGREEMENT FOR THE AVAILMENT OF THE MULTIPURPOSE LOAN FACILITY FOR THE "MULTI-PURPOSE LOAN FACILITY" EXTENDED TO THE ELIGIBLE EMPLOYEES.

WHEREAS, the Hon. Mayor Edgar S. San Luis endorsed said request to the august body and referred to the Committee on Finance, Budget and Appropriation and Committee on Laws and Ordinances, for discussion;

WHEREAS, presented to the committees, is the information that City Savings is a banking institution duly authorized and licensed by the Bangko Sentral ng Pilipinas to engage in extending multi-purpose loans to the LGU's like Santa Cruz;

WHEREAS, the Multi-purpose Loan Facility is a convenient method of promptly paying of loans by salary deduction from the LGU payroll.
