A RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET FOR THE RELEASE OF SERVICE RECOGNITION INCENTIVE (SRI) FOR FY 2024 FOR ELECTED OFFICIALS, PERMANENT AND CASUAL EMPLOYEES AMOUNTING TO SEVEN MILLION THREE HUNDRED THIRTY FOUR THOUSAND PESOS (Php7,334,000.00) FROM THE SAVINGS OF FUNDED VACANT POSITIONS OF DIFFERENT OFFICES TO OTHER PERSONAL BENEFITS SUBJECT TO EXISTING LEGAL LAWS, RULES AND REGULATIONS.

WHEREAS, Budget Circular No. 2024- 7 dated December 16, 2024 – provides Guidelines on the grant of Service Recognition Incentive (SRI) to all Government Employees for FY 2024 in the amount of Twenty Thousand Pesos (Php20,000.00);
