RESOLUTION NO. 503-S2024

A RESOLUTION APPROVING AND ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN CY 2025 OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA WITH A TOTAL AMOUNT OF P4,024,000.00

WHEREAS, the Municipal Mayor Hon. Edgar S. San Luis endorsed to the Sangguniang Bayan the Peace and Order and Public Safety (POPS) Plan CY 2025 of the Municipality of Santa Cruz, Laguna in the amount of P4,024,000.00 as contained in Resolution No. 4-S2024 of the Municipal Peace and Order Council (MPOC), Municipal Anti Drug Abuse Council (MADAC), End Local Communist Armed Conflict (ELCAC), Local Council for the Protection for Children (LCPC), Local Committee on Anti-Trafficking and Violation against Women and their Children (LCAT-VAWS);

WHEREAS, every province, city / Municipal POC, and Barangay POC is required to formulate a 3 year Program based on the Peace and Order and Public Safety Plan (POPS Plan)

WHEREAS, the main goal of the Peace and Order and Public Safety Plan is to strengthen the partnership and collaboration with the stakeholders of the Municipality by enhancing the organizational development of PNP, BFP, BJMP, MDRRM, DILG to improve the community awareness through community oriented and human rights based policing; to lower the crime rate in the community by reducing/eliminating human rights violation and make the Municipality of Santa Cruz, Laguna a prohibited free and safest place in the fourth district being as the capital town of Laguna and to eliminate terrorism while providing support to constituents, investors and visitors;

WHEREAS, perusal of the submitted plan reveals that the Municipal Peace and Order and Municipal Anti Drug Abuse Council aim to enhance the capabilities of the law enforcers by implementing programs and activities that will develop the skills, promote innovative solutions by using modern technologies and encourage people's participation in building a safe and drug free Santa Cruz
