RESOLUTION NO. 057-S2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN A MEMORANDUM OF AGREEMENT WITH THE NATIONAL BUREAU OF INVESTIGATION REPRESENTED BY NBI DIRECTOR JUDGE JAIME D. SANTIAGO FOR THE EXTENSION OF THE PREVIOUSLY SIGNED MOA FOR THE EXTENSION OF SATELLITE OFFICE UP TO DECEMBER 31, 2027.

WHEREAS, the Municipal Administrator Melvin Bonza as authorized by the Hon. Mayor Edgar S, San Luis endorsed the above-mentioned subject matter to the Sangguniang Bayan, for its consideration;

WHEREAS, Resolution No. 061-S2020 authorized the Hon. Mayor Edgar S. San Luis to sign and enter for the previous Memorandum of Agreement between the Local Government of Santa Cruz, Laguna and the NBI giving free space and support equipment and personnel for the use of the NBI Satellite Office in Santa Cruz, Laguna;

WHEREAS, it is the objective and policy of this municipality to give opportunity and service for the benefit of its constituents, employees and the general public.

NOW THEREFORE, on motion of Hon. Rizaldy N. Kalaw, (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by Hon. Norman T. Tolentino, Hon. Lea A. Almarvez, Hon. Ambiel John C. Panganiban and Hon. Esmeraldo C. De Las Armas, Jr. and with the approval of the members of the Sangguniang Bayan, it was.

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to sign a Memorandum of Agreement with the National Bureau of Investigation represented by NBI Director Judge Jaime D. Santiago for the extension of the previously signed MOA for the extension of Satellite Office up to December 31, 2027.

ORDERED: Let copies of this resolution be furnished the Honorable Mayor Edgar S. San Luis, the Municipal Treasurer, the Municipal Accountant, the Municipal Budget Officer, the Municipal Planning and Development Officer, National Bureau of Investigation and all other concerned offices, for their information and appropriate action.
