A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) THROUGH ITS REGIONAL OFFICE IV-A FOR THE IMPLEMENTATION OF AYUDA SA KAPOK ANG KITA PROGRAM (AKAP)

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Edgar S. San Luis to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, the Municipality of Santa Cruz, Laguna serves as an implementing agency for the AKAP Program in accordance with the processes and documentary requirements under DSWD MC No. 04, S 2024;

WHEREAS, in consonance with the request, the said agreement was discussed and deliberated by the members of the Committee on Social Welfare and Development, Family and Women of this sanggunian;

WHEREAS, after a careful study and deliberation of the said committee, this body found it advantageous to the welfare and benefits of the people of this municipality.

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Lea A. Almarvez (Chairman of Committee on Social Welfare and Development, Family and Women), duly seconded by of all the members present, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to sign and enter into a Memorandum of Agreement on behalf of the Municipal Government of Santa Cruz, Laguna, with the Department of Social Welfare and Development (DSWD) through its Regional Office IV-A for the implementation of Ayuda sa Kapok ang Kita Program (AKAP).
