A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND AMEND A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE IV-A (CALABARZON) REPRESENTED BY ITS REGIONAL DIRECTOR BARRY R. CHUA, M.D., TO IMPLEMENT THE SUPPLEMENTARY FEEDING PROGRAM.

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Edgar S. San Luis to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, the attached Memorandum of Agreement (MOA) between the Department of Social Welfare and Development Field Office IV-A (CALABARZON) and the Municipal Government of Santa Cruz, Laguna to implement the Supplementary Feeding Program;

WHEREAS, after a careful study and evaluation of the said agreement, by the concerned body, it was deemed proper to grant an authority to the Municipal Mayor Edgar S. San Luis to sign and amend an agreement with the Department of Social Welfare and Development Field Office IV-A (CALABARZON), advantageous to the welfare and benefits of the constituents.

NOW THEREFORE, on motion of the Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of the Committee on Health, Nutrition and Sanitation), duly seconded by Hon. Norman T. Tolentino, Hon. Ambiel John C. San Luis to sign and amend a Memorandum of Agreement on Behalf of the Municipal Government of Santa Cruz, Laguna, with the Department of Social Welfare and Development Field Office IV-A (CALABARZON) represented by its Regional Director Barry R. Chua, M.D., to implement the Supplementary Feeding Program.

RESOLVED FURTHER, That Article IV of the Memorandum of Agreement signed between the DSWD Field Office IV-A (Calabarzon) executed on July 12, 2024 under Doc. No. 250; page 51; Book 403 Series of 2024 before Atty. Ma. Carmencita C. Obmina-Muana, Notary Public for the City of San Pedro shall be amended as follows:

 Article IV. Effectivity. This MOA shall take effect upon signing of the parties and shall remain valid and existing from CY2024 to 2026, providing, it shall not exceed the Extended Payment Period, as stated further under the applicable GAA General Provisions, unless otherwise revoked or terminated by the parties.

RESOLVED FURTHERMORE, that in addition to the above amendment, the Memorandum of Agreement shall also take effect upon signing of the parties and shall remain valid and existing until the completion of the 120 feeding days for the 14th to 16th cycle implementation or within the applicable year, whichever comes first, unless otherwise revoked or terminated by either one of the parties.

RESOLVED FINALLY, that all other terms and conditions of the Original Memorandum Agreement and its amendments shall remain in full force and effect unless incompatible with the present amendments in which case, it shall be interpreted or modified accordingly in order to attain the purpose for which these amendments are established.
