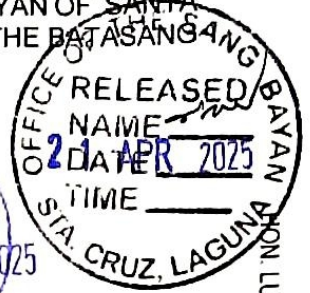

RESOLUTION NO. 090-S2025

A RESOLUTION AUTHORIZING THE ESTABLISHMENT AND NON-REMOVAL OF RETAIL STALLS FOR THE KESONG PUTI FESTIVAL FOR THE DURATION FROM APRIL 1, 2025 TO APRIL 13, 2025 OF MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, on March 31, 2025, Sangguniang Bayan Office received a letter from Hon. Mayor Edgar S. San Luis authorizing the non-removal of retail stalls during the celebration of the 21st Kesong Puti Festival;

WHEREAS, this will attract more investments to enhance local economic activities;

WHEREAS, the non-removal retail stalls will be established starting from April 1, 2025, until April 13, 2025;

WHEREAS, the Sangguniang Bayan is empowered to temporarily close roads or alleys pursuant to Section 21 (a) (c) of the Local Government Code of 1991;

WHEREAS, portions of Cailles Street shall be closed from Santa Cruz Bridge to the front of the Municipal Hall, J.P. Rizal Street (front of Escolapia Building);

WHEREAS, after a careful study and deliberation the same was recommended for its approval.

NOW THEREFORE, on motion of the Hon. Norman T. Tolentino (Chairman of Committee on Livelihood, Trade and Industry), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Alan T. Pamatmat, Hon. Lucena R. Odejar and Hon. Laura P. Obligacion and with the unanimous consent and approval of the members present, it was

RESOLVED: To authorize the establishment and non-removal of retail stalls for the Kesong Puti Festival for the duration from April 1, 2025 to April 13, 2025 of Municipality of Santa Cruz, Laguna.

ORDERED: Let copies of this resolution be furnished the Hon. Mayor Edgar S. San Luis, the Municipal Administrator, the Municipal Accountant, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Coordinator, the Business, Permit and License Office, the Public Information Office, SCTMO, PNP, Sangguniang Barangay of Poblacion III, Immaculate Conception Parish Church, DILG and all others concerned, for their information and appropriate action.
