RESOLUTION NO. 091-S2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND MEMORANDUM OF UNDERSTANDING ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE UNIVERSITY OF THE PHILIPPINES LOS BANOS, A NATIONAL UNIVERSITY OF THE PHILIPPINES, REPRESENTED BY CHANCELLOR, DR. JOSE V. CAMACHO, JR.

WHEREAS, this august body received an endorsement referring to the above subject matter;

WHEREAS, the attached Memorandum of Understanding (MOU) between the University of the Philippines Los Banos and the Municipal Government of Santa Cruz, Laguna for the implementation of project titled "Improving Agricultural Productivity and Competitiveness of Women Livelihood Operators through Gender-Responsive S&T Strategies" funded by the Philippine Council for Agriculture, Aquatic, and Natural Resources Research Development (PCAARRD);

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Livelihood, Trade and Industry of this sanggunian;

WHEREAS, after a careful study and deliberation, the said committee, found the project to be important in extending services that addressing the needs of women engaged in livelihoods related to in agriculture, aquaculture, and natural resources;

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Norman T. Tolentino (Chairman of Committee on Livelihood, Trade and Industry), duly seconded by Hon. Alan T. Pamatmat and Hon. Ambiel John C. Panganiban and with the approval of the members present, it was

San Luis to sign and enter into a Memorandum of Understanding on behalf of the Municipal Government of Santa Cruz, Laguna, with the University of the Philippines, Los Baños, a national university of the Philippines, represented by Chancellor, Dr. Jose V. Camacho, Jr.
