A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH EAEC - EMILIO AGUINALDO COLLEGE MANILA, A HIGHER EDUCATIONAL INSTITUTION, REPRESENTED BY JOSE PAULO E. CAMPOS, Ed. D. AND TITO CAPAYCAPAY, MAEd, RTRP FOR THE IMPLEMENTATION OF PHYSICAL THERAPY AND OCCUPATIONAL THERAPY SERVICE FREE OF CHARGE TO INDIGENT PEOPLE OF THE MUNICIPALITY

WHEREAS, received by the august body an endorsement referring to the above subject matter;

WHEREAS, the attached Memorandum of Agreement (MOA) between the EAEC - Emilio Aguinaldo College Manila and the Municipal Government of Santa Cruz, Laguna is designed for the implementation of Physical Therapy and Occupational Therapy Service free of charge to indigent people of the Municipality;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Social Welfare and Development, Family and Women of this sanggunian;

WHEREAS, after a careful study and deliberation of the said committee, this body found its importance in bringing its public services to the citizens;

WHEREAS, the said agreement is binding and should be implemented accordingly.

Campos, Ed. D. and Tito Capaycapay, MAEd, RTRP for the implementation of Physical Therapy and Occupational Therapy Service free of charge to indigent people of the Municipality;
