A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE WIRELESS ACCESS FOR HEALTH INITIATIVE, INC. REPRESENTED BY ITS TREASURER, JEANETTE A. LAZATIN, MD, MPPM.

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Edgar S. San Luis to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, the adoption and installation of WAH Digital Health Platform Software will serve as a mechanism to provide access to Philhealth's claim and reimbursements web-service and shall serve as a mean for Municipality of Santa Cruz, Laguna to adhere in DOH and PhilHealth regulations in compliance with Republic Act No. 11223 otherwise known as the Universal Health Care (UHC) Law;

WHEREAS, after a careful study and evaluation of the said agreement, by the concerned body, it was deemed proper to grant an authority to the Municipal Mayor Edgar S. San Luis to sign and enter into a Memorandum of Agreement with the Wireless Access for Health Initiative, Inc. represented by its Treasurer, Jeanette A. Lazatin, MD, MPPM.
