RESOLUTION NO. 106-S2025

RESOLUTION DECLARING A STATE OF CALAMITY IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, on May 23, 2025, a destructive fire occurred in the Santa Cruz Public Market, causing widespread damage and devastation to property, businesses, and critical infrastructure;

WHEREAS, the fire disrupted essential lifelines such as the food supply chain, electricity, potable water systems, transport and communication systems, and access to health and other critical services, which cannot be restored within twenty-four (24) hours;

WHEREAS, based on the criteria provided under Memorandum Order No. 60, S2019, and in accordance with Section 52(b) of Republic Act No. 7160, also known as the Local Government Code of 1991, the declaration of a state of calamity is justified;

WHEREAS, the Hon. Mayor Edgar S. San Luis of Santa Cruz has formally requested the Sangguniang Bayan to hold a special session to deliberate and act upon the declaration of a state of calamity:

WHEREAS, the Sangguniang Bayan recommend P15,000.00 for the affected stall owners and lessees and the amount of P5,000.00 for ambulant vendors and immediate relocation to continue the operation of their businesses and livelihood.

NOW THEREFORE, on motion of the Hon. Rizaldy N. Kalaw (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by the all the members present, it was

RESOLVED. AS IT IS HEREBY RESOLVED, to declare a STATE OF CALAMITY in the Municipality of Santa Cruz, Province of Laguna, as a result of the destructive fire that occurred on May 23, 2025 at Santa Cruz Public Market;

RESOLVED FURTHER, that this declaration shall serve as basis for the utilization of calamity funds and the implementation of emergency measures for relief, recovery, and rehabilitation of affected areas and constituents;
