RESOLUTION CONCURRING THE APPOINTMENT OF RET. JUDGE AGRIPINO G. MORGA AS MUNICIPAL ADMINISTRATOR OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA PURSUANT TO SECTION 454 (d) OF REPUBLIC ACT 7160 OTHERWISE KNOWN AS LOCAL GOVERNMENT CODE OF 1991 EFFECTIVE JULY 1, 2025.

WHEREAS, submitted for legislative action of the Sanggunian is the appointment issued by Municipal Mayor Joseph Kris Benjamin B. Agarao in favor of Ret. Judge Agripino G. Morga as Municipal Administrator effective July 1, 2025 for confirmation/concurrence;

WHEREAS, Section 454 par (d) of RA 7160, otherwise known as the Local Government Code of 1991, provides that heads of department and offices shall be appointed by the Municipal Mayor with the concurrence of the majority of the Sangguniang Bayan members subject to Civil Service laws, rules and regulations;

WHEREAS, the aforementioned was referred to Committee on Good Governance, Public Ethics and Public Accountability;

WHEREAS, after thorough evaluation, the Committee recommended for its approval;
