RESOLUTION NO. 379- S2025

A RESOLUTION APPROVING BARANGAY RESOLUTION NO. 15 – S2025 OF THE SANGGUNIANG BARANGAY OF PATIMBAO, ENTITLED: “A RESOLUTION AUTHORIZING THE REALIGNMENT OF FUNDS FROM THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) AND UTILIZATION OF TRUST FUND IN THE TOTAL AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) FOR THE IMPLEMENTATION OF THE CCTV PROJECT IN BARANGAY PATIMBAO, SANTA CRUZ, LAGUNA.”

WHEREAS, Barangay Patimbao, through its Sangguniang Barangay, has proactively identified a critical need to enhance the safety and security of its constituents and has duly enacted Resolution No. 15 – S2025, authorizing the realignment of funds from its Local Disaster Risk Reduction and Management Fund (LDRRMF) and utilization of Trust Fund in the amount of Three Hundred Thousand Pesos (P300,000.00) to finance the implementation of a Closed-Circuit Television (CCTV) Project within the said barangay;

WHEREAS, this CCTV Project is strategically designed to serve as a vital tool in bolstering public safety, strengthening disaster preparedness and real-time monitoring capabilities, and fostering a more secure and peaceful environment within the territorial jurisdiction of Barangay Patimbao. This initiative directly aligns with the general welfare mandate of local government units as enshrined in Section 16 of Republic Act No. 7160, also known as the Local Government Code of 1991;

WHEREAS, the establishment of a comprehensive CCTV system is not only a proactive measure for crime prevention but also a significant step forward in realizing the objectives of Republic Act No. 10121, the Philippine Disaster Risk Reduction and Management Act of 2010. This project will facilitate the adoption of appropriate technologies and measures designed to significantly strengthen disaster risk reduction, prevention, mitigation, and rapid response capabilities, ensuring the safety and well-being of our community;

WHEREAS, the Sangguniang Bayan of Santa Cruz, after careful and thorough evaluation, recognizes the validity, immense benefits, and overall consistency of the said Barangay Resolution with existing laws, rules, and regulations. The Sangguniang Bayan acknowledges the urgent need for this project and affirms its potential to greatly improve the quality of life for the residents of Barangay Patimbao, and therefore, the resolution merits immediate and favorable action;

NOW, THEREFORE, on motion of Hon. Rizaldy N. Kalaw (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by all the members of the Sangguniang Bayan, it was:

RESOLVED, as it is hereby **RESOLVED**, to **APPROVE** Barangay Resolution No. 15 – S2025 of the Sangguniang Barangay of Patimbao, entitled “A Resolution authorizing the Realignment of Funds from the Local Disaster Risk Reduction and Management Fund (LDRRMF) and utilization of Trust Fund in the total amount of Three Hundred Thousand Pesos (P300,000.00) for the Implementation of the CCTV Project in Barangay Patimbao, Santa Cruz, Laguna.”
